 - No Budget Committee Meeting held this month
 - Job Descriptions were updated in June. They will be sent to Policy Council and Board in August for approval.

- TANF grant year that ended on 6/30/2023 has been closed. We renewed the grant for the 2023-2024 service year to serve 13 children in Idaho.
- Working on budgets for the 2024-2025 Head Start Continuation Grant Application
- In process of implementing Gusto as our new online payroll, human resources and onboarding system. First payroll with them was on July 12. Staff will not enter or use the Gusto website until some kinks are worked out.
- Began annual price comparisons
- Continued to renew CACFP budgets and contracts in Utah and Idaho
- Annual Audit held July 10-12 that went well
- Began working on Fiscal Workplans, Program Improvement Report and Program Information Report
- Received COLA and Quality Improvement Funds. Waiting to disperse them until we have everything settled with Gusto.
- Received notice to remove our COVID-19 vaccine and testing requirements
- Completed Final Program Progress Reports for grant period that ended 3/31

6. Director's Report:

- Working on Program Reports during the summer months including PIR (Program Information Report), Program Improvement and our Baseline Grant.
- Our audit was held a couple of weeks ago and went well.
- We are getting ready to start providing services again next month.
- We are still accepting children. If you know of anyone that might want to apply, please encourage them to do so.

7. Board Report:

- Brooks is our new Board Member.
- Board met June 27 and approved all policies presented including the Child Abuse and Neglect Policy, Board May Meeting Minutes, Family Development Outcomes, Centerbased Child Development Outcomes and the Homebased Child Development Outcomes.
- The upcoming audit was discussed. Glad to hear it went well.
- Board does not meet in July. Their next meeting is scheduled for August 22.

8. Policy Council Concerns & Other Discussion Items:

- A member of Policy Council has a child that has been on the Homebased waiting list and asked for more information about if/when their child will be enrolled. We will follow up with this parent.
- Homebased services include a Family Educator visiting the child's home once a week to
 provide guidance and activities to help the child grow toward set goals and to support
 the parents in being the best parents they can be as their child's first teachers. They also
 have monthly socializations for the enrolled children to be able to play together.

9. Community Report:

- Every Saturday: free events through the Jump Utah Program at museums, parks, swimming pools, etc. all held in the Ogden, Utah area.
- July 21: Hay Days in Tremonton
- Saturday, July 22: Mendon Pioneer Days with a parade at 11:00am. There will be activities, games, food trucks, etc. at the park and town square throughout the day and fireworks that night.
