5. Budget Committee/Fiscal Report - Melanie Wells/Symphony Correia

Budget Committee Meeting was not held this month. Job Descriptions were updated in June and will be sent to Policy Council and Board for approval in August. We closed our TANF Grant that ended 6/30/2023 and renewed our TANF contract with Idaho Head Start Association for the 2023-2024 school year to serve 13 children in Idaho in the amount of \$147,524 which is great because it reflects an increased amount of funding per child. We began working on budgets for the 2024-2025 Head Start continuation grant application. We are still in process of implementing Gusto as our new payroll, onboarding and human resources system. We had our first pay day with them on July 12. Since then, we have not had any staff enter time or use the app or Gusto's website until we are able to work out some kinks. We began our annual price comparisons and continued the annual renewal of our CACFP programs in Utah and Idaho including our budgets and contracts. We had our Audit on July 10-12 which went pretty well. We began working on Fiscal Workplans, the Program Improvement Report and the Program Information Report (PIR). We also received our COLA and Quality Improvement Funds and are waiting to disperse those until we have everything settled with Gusto. We got a notice to remove our COVID-19 vaccine and testing requirements which was also very nice. We submitted Final Program Progress Reports for HE Grants that ended on March 31.

6. Director's Report – Sarah Thurgood

We are working on program reports during the summer including the PIR, Program Improvement Report and the baseline grant which involves quite a writing process. These will all

come to Board and Policy Council for review and approval sometime in August or September. We had our audit a couple weeks ago and it went really well. We had never met the two auditors that were here this time. They were great and on top of it. We are just moving through the summer and getting ready to start providing services again this next month. We are still accepting children. If you know of anyone that would like to apply and hasn't, feel free to encourage them to. Some of our classrooms are getting full and some still have openings.

7. Board Report - Brooks Bodily

Brooks is the new Board Member. Board met on June 27. They approved all of the policies that were presented that night including the Child Abuse and Neglect Policy, Board's May Meeting Minutes, the Family Development Outcomes, Centerbased Child Development Outcomes and Homebased Child Development Outcomes. We discussed the audit that was upcoming. That was good to hear it went well. Thanks to Andy and Symphony for your time and involvement in that. Board will not have a meeting in July. Their next meeting is scheduled for August 22.

8. Policy Council Concerns & Other Discussion Items - Policy Council Representatives

A Policy Council member has a baby that is going to turn two soon and has been on the waiting list for Homebased. They asked if Homebased is different from Centerbased. Homebased services involve a Family Educator that comes to the home once a week. They work with the parents who are the teachers of their child. They bring resources and activities to help you become the best parent you can be. They also have socializations once a month so parents can be around other parents who have children of similar ages. When does your child turn two? He will turn two on September 30. He would still be in the age range of Early Head Start Homebased. Which county do you live in? Cache. We will get with you after the call to get your name and phone number to make sure you are taken care of because we should still have some slots available in the Homebased program in your area.

9. Community Report - Policy Council Representatives
