Sometimes she performed the duties of the Teacher Assistant, sometimes the Classroom Assistant and sometimes just an extra. She has learned a lot. Karen has been with Bear River Head Start for about a year and 3-4 months. She has learned so much since she first started. She has had a great time and there have been so many learning opportunities and Karen is taking advantage of all of it. She is a current student at Utah State University so she is not working a whole lot right now. Karen is studying Elementary Education and also getting a certificate to teach English to speakers of other languages. Her graduation date is set for 2028. Policy Council asked about Karen going to just about all of the classes. With a graduation date of 2028, has she missed some classes? Karen said she is going to be a sub? Does she have the qualifications to do that and teach the whole class? Karen has been working for us as a Teacher Assistant until she graduated. By our standards, a Teacher must have a minimum of an Associate's Degree in Early Childhood Education or the equivalent. We send the transcripts of our teaching staff to Utah State University where they check the qualifications using their Career Ladder. Karen was not qualified to be a Teacher when she was first hired. Now that she has finished her Associate's Degree, she is requesting to transfer. She is also continuing her education to get a Bachelor's Degree in Early Childhood Education for Elementary School Teaching which will qualify for us as well. Karen also mentioned she has worked in almost all of the Head Start classes. She was a substitute Teacher Assistant and traveled to all 21 of our classes, as needed, when she could. She'll do the same as an On-Call Teacher although she can't sub quite as much as she used to now that she's back in school.
